IFLA, the global voice of the library community, has a section on Library Services to People with Special Needs (LSN). The IFLA LSN Section provides an international forum for the discussion of ideas, sharing of experiences and development of tools designed to promote and improve the effectiveness of library and information services to special needs groups, and the promotion of national and international cooperation at all levels.

These groups include, but are not limited to, people who are in hospitals, nursing homes, and other care facilities; **people in prisons**; people who are experiencing homelessness; people with physical disabilities; people who are deaf, hard of hearing, or deafblind; people with dyslexia; and people with cognitive and mental disabilities.

One ongoing project of the section is updating the IFLA Guidelines for library services to prisoners.

The training manual discusses ways to advocate for the prison library as a program environment that is based on a needs-based library service philosophy grounded in correctional theory. Library-based programs such as consequential thinking, book discussions, writing-as-therapy, humor-as-therapy in the correctional environment, and the respectful treatment of women will be examined. The instructor also shares examples of course materials, curricula, and post-program data analysis.
