In the beginning I would really like to address my sincere thanking to IFLA for offering me such a valuable chance to attend IFLA conference for the first time in my professional life.

Attending IFLA conference 2010 was an opportunity to meet other people like me. That is to say, to meet people doing something similar to what I am doing. At the same time, those people are not doing exactly the same thing, as they are all coming from other places.

To summarize and to conclude, i would really like to say that IFLA 2010 was not only just a conference for me, but it was a real chance to attend seminars, lecture and to know some professionals from all over the world as well.

IFLA gave us "the Guarantees" and the practitioners the chance to refresh our skills and keep abreast of new tools and methodologies. IFLA provided us a real opportunity to network with others in the discipline.
