Library Director Malmö City Library

I want libraries to collaborate for social sustainability and I want to represent all the world's libraries in these matters. For me, the expression freedom of speech is not enough, but rather I want the library to be a place where the concept of opinion equality

is tested and practised. This means libraries actively contributing to removing the obstacles that stand in the way of people's natural right to express their own opinions. Such barriers can be made up of a digital exclusion just as much as never having had the chance to learn to read and write. It can be poverty and it can be social exclusion on the basis of sexuality, age or cultural background.

The role of libraries as free, including, multicultural, multilingual and educational learning centres is therefore very close to my heart.

Libraries must be free from commercial interests. Instead, the library should be a resource that provides everyone free access to information, knowledge and culture. This gives people the opportunity to use their democratic right to develop, think, speak and write freely.

I want to contribute to those in positions of power, authorities and individuals getting increased knowledge about the tasks and functions of the libraries. I want to contribute to strengthening the libraries' circumstances and opportunities. This can be done by promoting appropriate legislation and funding and by spreading knowledge about the activities and effects of the libraries. It can be done, for example, by producing factual material, surveys and reports, as well as by the awarding of library prizes. To increase library-related research, research initiating funds are allocated for the production of research applications.

I want to professionalise and develop communication efforts about IFLA and its importance to libraries, librarians and ultimately to human knowledge. I want to contribute in IFLA by strengthening the role of libraries in society and highlight and promote the importance of libraries for cultural heritage, innovation and societal impact.

Finally, If I will be elected to the IFLA Governing Board, I will work for bringing a userdriven Nordic Public Library perspective in to the international library field.

Career Summary

My name is Torbjörn Nilsson. I have been the head of Malmö City Library for six years and, from 1 May 2017, am also the head of all the public libraries in Malmö. I am also former Vice-President of the Swedish Library Association, on whose board I was a member 2012-2017. In 2017 I was elected as a member of the IFLA Governing Board.

I am an academic with graduate qualifications in both library science and cultural sciences. I have many years' experience of being the head of various public cultural organisations in Sweden.

The most important part of my career is that which is going on now and I would therefore like to describe my library in the following way: For a week in May 2015, Malmö welcomed 40 unaccompanied refugee children, mostly from Syria and Afghanistan. A little later, a week in October of the same year, 1,709 unaccompanied refugee children were welcomed. That year, 162,877 asylum seekers arrived in Sweden, most of them coming to Malmö over the Oresund Bridge.

Though all this was happening a while ago, I am proud to say that my city, Malmö, and our libraries still has the ability to reset and adapt our activities and prioritise people who most need our services. An example from the libraries in Malmö; we were the first in Sweden to lend out books to migrants without documentation.

Our philosophy at Malmö City Library is to get more visitors to stay in our library longer -to work, learn, create and experience culture. This requires a wide range of facilities, multi skilled staff and a welcoming environment. Over the last few years, we at Malmö City Library have built up a new digital learning environment, 3 new ultra-modern departments for children and young people. We have also created an e-book app for children with Stockholm Public Library. We work in learning teams and are known for working internally with a system to help each other with skill development.

Since over 178 countries from all over the world are represented in the population of Malmö, the construction of the communicative library is the next big challenge for me and the libraries in Malmö.



Rocky Ralebipi-Simela (South Africa)

National Librarian and CEO National Library of South Africa

As a member of the IFLA Governing Board, I will be a champion of libraries in Africa and the world. I will not only be a voice to share the African experience, heritage and knowledge, but also learn from other libraries and librarians to influence and improve the

state of libraries in Africa and the world.

I am committed to engaging and implementing the ethos of the IFLA Global Vision in which I participated extensively. My support of the 10 opportunities highlighted in the Global Report Summary will be strengthened by the experience I gained in the implementation of the United Nation's Sustainable Development Goals based projects at the NLSA.

Firstly, the Global Libraries supported programme called Mzansi Libraries On-Line (MLO). This programme put technology in almost 700 libraries in South Africa, changing the lives of the communities accessing them. Secondly, the Durban Communique (2018) and its predecessor the Cape Town Declaration (2015). This initiative of the South African Government involves all Ministers responsible for libraries in the AU community working together to improve public libraries in support of the AU Agenda 2063: The Africa We Want.
