## Celebrating Professor Kgomotso H. Moahi: A Pioneer in African LIS and Higher Education Leadership



On November 28, 2025, Professor Kgomotso H. Moahi became the first woman to assume leadership of a public institution in Botswana, being inaugurated as the 2nd Vice Chancellor of Botswana Open university (BOU). Her elevation to this position comes after decades of leadership at the University of Botswana, where she held the title of Dean of the Faculty of Humanities and became the first Motswana woman to attain the status of Full Professor in Library and Information Science (LIS). She has a PhD from the University of Pittsburgh and has occupied significant executive roles such as Deputy Vice Chancellor and Acting Vice Chancellor. Currently, she is leading BOU's 2036 Strategic Framework to promote inclusive lifelong learning.

In addition to her administrative accomplishments, Professor Moahi is a prolific researcher whose research connects Information Technology with Social Development. She has produced more than 80 papers concentrating on health informatics, information ethics and the preservation of African traditional knowledge. She is a pivotal role in national policy having contributed to Botswana's Maitlamo (National ICT Policy) and now heads the creation of the national Open Data Policy. Through her comprehensive research and guidance of other LIS professionals, she continues to be a prominent champion for the ethical use of technology and open science across the SADC area.

**Mr. Khutsafalo Kadimo** serves as the Senior Librarian, Research Support Services in the University of Botswana's. He has consistently advocated for evidence-based research, achieving international recognition in 2023 as a Cunningham Memorial International Fellow by the Medical Library Association (USA), also he currently serves as the World Health Organization|Research4Life Developing Countries(Group B) Representative, EIFL Country Copyright and Open Access Coordinator, and Secretary fir the Botswana Library Consortium. The year 2025 saw Mr Kadimo being elected to serve as the President of The Association for Health Information and Libraries in Africa (AHILA) at the conference held from September 30 to October 4, 2025, in Lusaka, Zambia. Following his tenure as Vice President, Kadimo currently directs a network of health information experts spanning over 45 nations. His election represents a shift toward a more digitally integrated future for African medical libraries. Under his leadership, AHILA is set to prioritize digital health literacy and strengthen the Network of African Medical Librarians (NAML), ensuring that high-quality health and medical data is accessible to those who need it most.

Advocacy for a Presidential Library: The LIS community has long championed the establishment of a Presidential Library in Botswana. The idea was first introduced in 2018 by the **Botswana International University of Science and Technology (BIUST)** Library through a project known as The Presidential Collection @BIUST . This initiative laid the foundation for a premier repository of textual records, drawings, paintings, photographs, artifacts, and other visual materials that capture and preserve the legacy and eras of all Botswana's presidents. In June 2025, the Government of the Republic of Botswana took a decisive step by authorizing creation of a Presidential Library through legislation. The Botswana National Library Services (BNLS) and the Botswana National Archives & Records Services have been mandated to lead this national initiative.A multi-stakeholder task team has been convened, with key responsibilities that include reviewing the current National Library Service Bill and preparing submissions for parliamentary deliberation, as well as offering guidance on the architectural and design framework of the Presidential Library. This development marks a significant milestone for the LIS sector in Botswana.

## University of Cape Town- Leading Change for Social Justice in Library Education

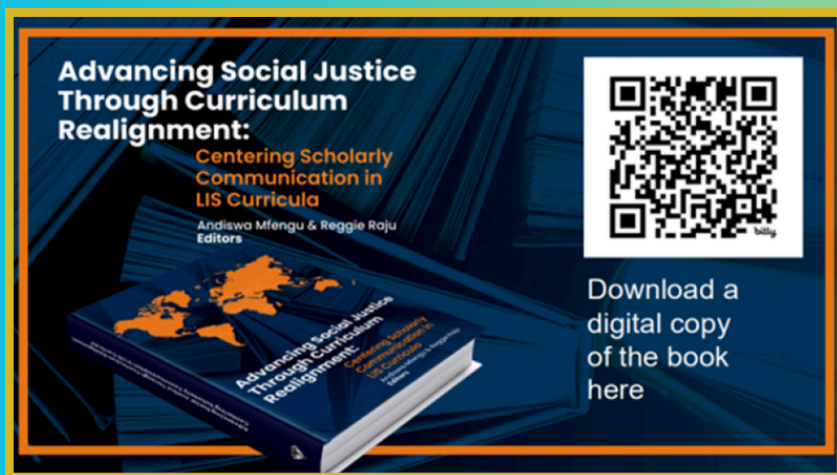

A new open-access book published by the University of Cape Town (UCT), featuring prominent Sub-Saharan African scholars, establishes a roadmap for decolonised and equitable Library and Information Science (LIS) education across Sub-Saharan Africa. The book, **Advancing Social Justice Through Curriculum Realignment: Centering Scholarly Communication in LIS Curricula** (UCT Libraries Press) addresses an urgent need to modernise LIS curricula and places African scholarship at the forefront of the global movement for equitable access to knowledge. The system through which research is created, evaluated, disseminated, and preserved is no longer a niche topic. It is now viewed as a crucial tool for knowledge democratisation and inclusive participation in global knowledge systems. The book argues that LIS curricula must be realigned to prepare the next generation of professionals to lead this transformative change right from the start of their careers. A major highlight of this collection is the significant contribution from leading LIS educators and practitioners across the Sub-Saharan African region, demonstrating the continent's thought leadership on issues of social justice and decolonisation. Their collective work forms a practical and theoretical foundation for curriculum reform that is locally relevant and globally resonant.

The book edited by Dr. Andiswa Mfengu and Dr. Reggie Raju from the University of Cape Town (UCT) is a direct outcome of a focused scholarly event at the 2nd Global Summit on Diamond Open Access held at UCT. It has achieved global relevance through deep inclusivity featuring 19 essays by 23 authors spanning Africa, Latin America, Europe, North America, and Australasia. The collection shatters mainstream academic norms by promoting multilingual engagement, with essays written in English, Spanish, Portuguese, and Setswana. This, along with the accommodation of varied English styles, ensures the book reflects the true linguistic and cultural diversity of the world's scholarly community. The collaborative success of this book is a testament to the fact that African library professionals are not just participants in the global conversation; but are actively shaping it. His work focuses on knowledge societies, indigenous knowledge systems, digital inclusion, and open scholarship, and he has mentored emerging African LIS professionals while facilitating workshops, webinars, and conference sessions across the continent.. Consequently, Dr. Chisita plays an active leadership role in professional associations. He is a Standing Committee Member of the IFLA Indigenous Matters Section (IFLA-IMS) and serves as Secretary of the AfLIA Library Education and Training Section (LETIS)

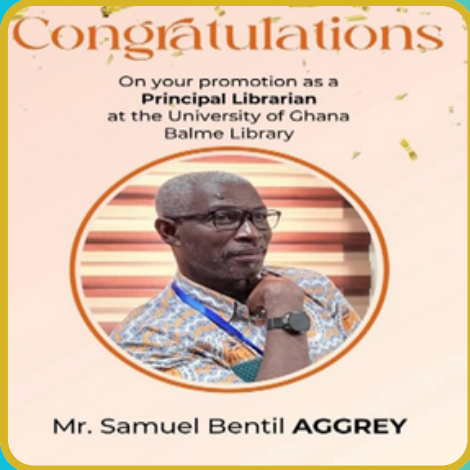




# Ghana Stories

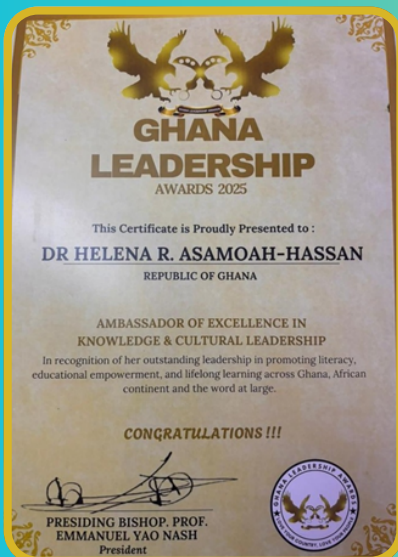




**Dr. Helena Asamoah-Hassan**

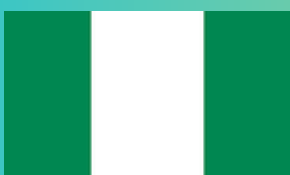

### Knowledge Empowering Youth Trust Receives the Library of Congress Literacy Award

Since 2008, Knowledge Empowering Youth (KEY) has expanded access to literacy for children in under-resourced communities through libraries designed as dynamic learning environments. Operating in 46 schools, KEY reaches more than 57,000 students and 1,300 teachers with a model that addresses key education gaps by combining curated book collections, technology, structured literacy programming, and student leadership frameworks adaptable to local contexts – equipping learners to thrive nationally and globally.

In recognition of this work, KEY has been named a 2025 Library of Congress Literacy Awards Successful Practices Honoree for its innovative methods and effective practices to promote literacy. The award acknowledges KEY's transformation of underfunded school libraries into vibrant, techno-integrated hubs in Kenya, Ghana, and Tanzania, which serve as an inspiring model for others interested in literacy promotion. Built on standardized yet flexible systems and grounded in school and community ownership, the model enables local capacity building, sustainability, and cost efficiency. As a result, KEY is further known for its exemplary, innovative, and replicable strategies to promote literacy in underserved communities, demonstrating a scalable approach that strengthens literacy, life skills, and civic engagement across diverse settings

## The National Information Workers Association of Namibia (NIWAN) advances capacity building through strategic partnerships



NIWAN has demonstrated an unwavering commitment to strengthening the skills and professional competencies of all Information Professionals in Namibia and beyond. The following are some of the Capacity building programmes undertaken so far:

- NIWAN student drive was an initiative to advance students representation in the association, coaching and mentorship efforts
- Awareness to all new members about what the association is all about, benefits and their expected role in helping to greater heights as members.
- With the support of the International Federation of Library Associations and Institutions (IFLA), NIWAN was able to undertake a training programme on Measurement, Evaluation and Demonstrating the impact of Library Services. .
- Financial Wellness Session which was held by the National Information Workers Association of Namibia . The session was held on Friday, 20th September 2024
- Libraries and Sustainable Development Goals session which was held on 12th June 2025 were 20 Library and Information Professionals trained by UNDP's focal person.
- NIWAN officially launched and held a Research Writing and Publishing Seminar which took place on the 25th September 2025. The session was attended by 50 participants.
- Enhancing Library Impact through Partnership: Building a shared future for Africa session which was held on 4th July 2024 and was attended by 91 participants from across the globe.
- Building Bridges, crafting our Future: Exploring the power of collaboration among Libraries and Information Science Professionals. Customer Care in Libraries, a session that was delivered in collaboration with representatives from Namibia, Rwanda and Zimbabwe. This was attended by 130 participants from all over Africa.
- Effective Communication in the ERA of AI- this was delivered in collaboration with colleagues from Nigeria and South Africa and was attended by 150 participants from across the globe.
- In Collaboration with AFLIA, about 10 Namibian Librarians were enrolled for the course "Advancing Open knowledge in Africa through Persistent Identifiers and Open Research Infrastructure".

## Technical Workshop: Improving Repository Infrastructure and Data Management in Ugandan Universities

**Mr. Kamanda Francis**, Assistant Librarian at Kyambogo University Library, recently participated in a high-level technical workshop organized by the Consortium of Uganda University Libraries (CUUL). Held from 8th–10th December 2025, the training brought together repository managers and IT staff from over 15 Ugandan universities. Funded by the Invest in Open Infrastructure (IOI) Fund and hosted at the Uganda Christian University’s Ham Mukasa Library, the workshop focused on the theme: “Improving Repository Infrastructure and Data Management in Uganda Universities.”

The intensive sessions provided hands-on training in DSpace installation and upgrades, community and collection architecture, content (item) management, and the technical administration of registries and user permissions.

### Strategic Recommendations and Key Observations

As a result of the training, several critical benchmarks were established to modernize institutional repositories (IRs) across the region:

**System Upgrades:** While most IRs were running DSpace versions 7.6.2 or 8.2, a transition to DSpace 9.0 was strongly recommended to leverage the latest security and functional enhancements.

**Persistent Identifiers:** A push for institutions to subscribe to Handle services was identified as a priority to ensure long-term, reliable access to digital assets.

**Metadata Excellence:** Most repositories were found to be compliant with Dublin Core and CORE vocabularies, maintaining high standards for global discoverability.

**Analytics and Visibility:** The workshop recommended the integration of Google Analytics or Matomo to better track usage and demonstrate the impact of research outputs.

**Policy and Licensing:** Participants were urged to publicly document their IR policies and customize default DSpace deposit licenses to align with their specific institutional mandates.

This collaborative initiative proved immensely beneficial, bridging technical gaps and fostering a unified approach to open access among Ugandan university libraries





Professor **Joseph Kiplang'at**, PhD, currently serves as the Vice Chancellor of Kenya Highlands University, having been installed on April 17, 2025. A distinguished scholar in Information Science, he previously dedicated eight years to senior leadership as the Deputy Vice Chancellor at both the Technical University of Kenya and Africa International University. His academic contributions include extensive publications in refereed journals and books, alongside his role on the Editorial Board for Electronic Library.

Professor Kiplang'at is a prominent figure in the global LIS community, holding memberships in the Kenya Library Association and the Dublin Core Metadata Initiative (DCMI). He is a frequent speaker and researcher, recently presenting on the 4th and 5th Industrial Revolutions in LIS education and KM curriculum frameworks at major conferences like SCECSAL. Beyond research, he remains committed to mentorship through doctoral supervision and external examination for universities worldwide.



**Mr. David Kipchirchir Koech** is a dedicated library professional at Kabarak University's Daniel Toroitich Arap Moi Library and an active member of the Kenya Library Association (KLA). As the founder of the Library Matters Initiative Africa (LMI-AFRICA), he is a passionate advocate for Open Access and Open Educational Resources (OER) across the continent.

The year 2025 marked a period of significant recognition for David, beginning with his selection as the Distinguished Librarian of the Month for April by the Librarian Spotlight Africa (LSA) initiative. His commitment to the field earned him a prestigious scholarship from the University of Minnesota's Center for Open Education Network (OEN) to specialize in open librarianship. Additionally, his expertise is recognized internationally through his appointment to the INFOLIBNET Advisory Team in Ethiopia, where he contributes to the development of information networks.
