It is led by an elected Chair who represents the region on the IFLA Regional Council and amplifies Africa's priorities on the global stage. The IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC) unites passionate library professionals across the region to champion professional development, advocacy, and collaboration. Through their work, African libraries are not just part of the global conversation, they are shaping it.

#### **Action Plan:**

At the core of the SSA RDC's work are partnerships and collaborations that strengthen and sustain the library and information profession. Our action plans focus on developing programmers that demonstrate the value of libraries, highlight emerging trends across the region, and connecting partners with IFLA's wide range of resources and tools. In doing so, we engage with colleagues and organizations both within Africa and beyond, fostering the exchange of ideas and mutual learning. Equally important, our strength lies in capacity building, supporting volunteers and professionals to grow through webinars, workshops, and initiatives such as Webinar 3.

#### 2. HIGHLIGHTS OF OUR WORK (2023–2025 TERM)

Through our activities, the SSA RDC established itself as a visible and proactive regional voice, championing the vital role of libraries in advancing sustainable development, fostering professional growth, and safeguarding cultural heritage. Our initiatives strengthened collaboration, built capacity, and created opportunities for libraries and information professionals to engage meaningfully at both regional and global levels. Below are highlights of the work we carried out during the 2023–2025 term.

Strengthening Libraries for Sustainable Development: At the 2024 UN High-Level Political Forum, IFLA spoke up for libraries as essential partners in achieving the UN Sustainable Development Goals (SDGs). The SSA RDC joined hands with other regions to engage ministers, ambassadors, and UN agencies reminding the world that libraries are more than places to store books; they are engines of change for education, equality, and access to information, as well as essential partners in achieving the SDGs. This built on the Nairobi Workshop that was held in October 2023 under the theme "Towards a Strong and Sustainable Regional Library Field", which shaped our 2023–2025 operational strategy around resilience, inclusion, and SDG alignment.

•Strengthening Libraries Across Africa: The SSA RDC partners with libraries, associations, and professionals across the region to share knowledge, highlight the value of libraries, and provide training for volunteers. Together, we're building a stronger, more sustainable library and information profession for Africa's future.

Capacity Building & Mentorship: Delivered targeted webinars on professional growth, mentorship, and advocacy including the high-impact "Mentorship and Collaboration for Professional Development" webinar (April 2025) in collaboration with CPDWL, which informed the draft SSA RDC Mentorship Strategy.

Collaborations & Networks: Strengthened partnerships with AfLIA, SCECSAL, CPDWL, IFLA MLAS, AVMS, ENSULIB, Unisa, and others, while supporting efforts to revitalize national library associations, such as in Lesotho.

Cultural Heritage & Climate Action: Co-organised regional side events with the Climate Heritage Network (CHN) during the African Climate Summit 2 (ACS2) in Addis Ababa, alongside a capacity-building workshop for LIS professionals hosted by Addis Ababa University.

**Knowledge Sharing:** The committee Published monthly newsletters to showcase LIS professionals and students' work across the region and contributed to the first edition of the IFLA Guidelines for Green Libraries (ENSULIB).

#### **Climate Action and Capacity Building in Ethiopia**



# IFLA SSA RDC and CHN – Africa & Arab States Secretariat at the African Climate Summit 2 (ACS2)- Ethiopia, Addis Ababa

The IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC), in partnership with the Climate Heritage Network (CHN) Africa and Arab States Secretariat, successfully convened two high-level side events during the African Climate Summit 2.

(ACS2) in Addis Ababa, followed by a capacity-building workshop hosted at Addis Ababa University from 8th to 10th September 2025. This collaboration emerged from the SSA RDC's broader commitment to fostering cross-sectoral partnerships to strengthen the visibility of libraries in climate action, cultural heritage, and community resilience.





The SSA RDC was well represented at the events by a team comprising Dr. Monica Mensah Danquah (Chair of the Committee), Dr. Buhle Mbambo-Thata (Member of the Committee), Dr. Ayanda Lebele (Immediate Past Chair of the Committee), Ms. Lindy Nhlapo (Regional Council Representative), and Ms. Nthabiseng Kotsokoane (Member of the Committee). The team's collective presence and contributions significantly enhanced the visibility of the SSA RDC and IFLA, and underscored its commitment to championing the role of libraries in climate action and cultural heritage initiatives across the region......

#### **Side Events**

The first side event, themed "Heritage in Climate Policy- Aligning NDCs with Culture-Based Adaptation," took place on 8th September. It brought together policymakers, heritage experts, and LIS professionals to advocate for the integration of cultural heritage into African climate policies and finance frameworks. The session highlighted the role of libraries as inclusive spaces for climate education and concluded with calls to institutionalize heritage considerations within African climate strategies.





The second side event, held on 9th September and themed "Mobilizing Culture and Heritage for Climate Resilience: African Solutions from the Ground Up," spotlighted community-driven and heritage-based approaches to climate adaptation. It showcased African-led grassroots models, emphasized the importance of indigenous knowledge systems, and encouraged stronger collaboration between cultural heritage sectors, local governments, and libraries to drive sustainable, community-based climate solutions.







#### The Workshop

On 10th September, the collaboration culminated in a workshop titled "From Insights to Action - Advancing Professional Networking for Advocacy and a Sustainable LIS Service in Sub-Saharan Africa." Co-organized by the IFLA Africa Office, SSA RDC, the University of South Africa, and hosted by Addis Ababa University, the workshop brought together LIS professionals from across the region. Participants explored the role of libraries in climate action, built professional networks, and developed advocacy skills to champion sustainability and resilience within their institutions and communities. Many participants expressed interest in joining IFLA and contributing to future regional initiatives.





Collectively, these events positioned libraries and information professionals at the heart of continental climate and cultural heritage conversations, created strong visibility for the SSA RDC as an active regional committee, and forged enduring partnerships with CHN, ICOMOS, ICLEI Africa, Unisa, and Addis Ababa University. This milestone collaboration reinforced the transformative potential of aligning climate, culture, and knowledge institutions, and affirmed the critical role of libraries in advancing climate education, heritage preservation, and community resilience in Africa. Initial blueprints and action steps were outlined during the discussions to guide the process of initiating and building the Ethiopia Library association. The SSA RDC team expressed readiness to provide technical guidance and mentorship support, including convening a follow-up meeting with the Ethiopian team to map out the way forward. It was also proposed that the emerging association could be paired with leaders of exemplary library associations within the Sub-Saharan Africa region to share best practices and mentorship for sustainable growth.

#### Conclusion

The joint engagement between the IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC) and the Climate Heritage Network (CHN) at the African Climate Summit 2 and Addis Ababa University successfully achieved its core objective of raising awareness about the critical role libraries play in climate change discourse and action. The sessions underscored not only how libraries can serve as hubs for climate education and community resilience, but also how climate change directly affects libraries and their collections, threatening the preservation of cultural and documentary heritage. Importantly, the events highlighted the need to strengthen IFLA's footprint in Ethiopia, fostering a stronger national presence and supporting the development of professional structures and networks that can anchor sustained library advocacy and climate action efforts in the country. Furthermore, the team was able to initiate meaningful conversations that are expected to evolve into strategic partnerships and collaborations with key stakeholders across the heritage, cultural, and environmental sectors.

This marks a significant step toward embedding libraries more firmly in Africa's climate and cultural heritage agenda, while laying the foundation for future joint initiatives that will amplify the voice and impact of libraries across the region. The SSA RDC looks forward to building on this momentum through sustained collaboration and expanded partnerships in the years ahead.

## SSA RDC at IFLA WLIC 2025 & IFLA WLIC 2026 Highlights (full report on Appendix 2)

The IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC) held its crucial Business and Caucus Meetings during the IFLA WLIC 2025 in Astana, effectively concluding the 2023–2025 term. Chaired by Dr. Monica Mensah Danquah (Chair-Elect), the meetings highlighted significant achievements and set a clear strategic path forward, earning commendation from the IFLA leadership.

#### Key outcomes included:

Strategic Achievements: The term concluded with notable successes, including the development of a draft SSA RDC Mentorship Strategy, expanded partnerships, and strong contributions to global initiatives like the Green Library Guidelines.

**Future Planning:** Discussions focused on preparation for SCECSAL 2026 in Zambia and strengthening regional participation in global advocacy, such as Voluntary National Review (VNR) processes.

**Call for Unity:** The Caucus meeting strongly emphasized the need for enhanced communication and greater inclusivity to ensure all diverse regional voices (Anglophone, Francophone, Lusophone) are reflected in the committee's work.

Focus on WLIC 2026: Members were strongly urged to begin early preparation for the next Congress in Busan, South Korea, including proposing themes for the SSA RDC's Open Session to maximize Africa's impact on the global LIS stage.

## Appendix 1: Sub-Saharan Africa Regional Division Committee Handover Report 2023-2025

#### 1. Introduction

This document serves as the official handover report for the IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC) for the 2023–2025 term. It presents a comprehensive account of the committee's strategic priorities, activities, collaborations, achievements, challenges, and ongoing initiatives. It also provides recommendations for the incoming Chair and members to ensure continuity and sustained progress.

#### 2. Overview of the Term

The 2023–2025 term was marked by a strong focus on advancing IFLA's global vision within the African context, aligning efforts with the United Nations 2030 Agenda and the African Union's Agenda 2063. Under the leadership of Chair Ayanda A. Lebele, the committee prioritised advocacy, professional capacity building, sustainable development, and enhanced regional cooperation among library and information science (LIS) stakeholders.

#### 3. Key Strategic Priorities

The committee's work was guided by the following strategic objectives:

- 1.Strengthening capacity building and professional development for LIS professionals in Sub-Saharan Africa.
- 2. Fostering partnerships with regional library associations, IFLA sections, and global bodies.
- 3. Promoting equity, diversity, and inclusion within the LIS sector.
- 4. Supporting the contribution of libraries to the UN 2030 Agenda and African Union's Agenda 2063.
- 5. Advocating for improved access to information, literacy, and digital skills across the region.

#### 4. Meetings and Deliberations

The SSA RDC convened regular business meetings and ad-hoc planning sessions to monitor progress, plan events, and respond to emerging opportunities. Meetings were primarily conducted virtually via Zoom or MS Teams, with decisions and action points documented in official minutes. Discussions covered programme implementation, collaboration proposals, advocacy campaigns, and ongoing projects.

#### 5. Collaborations and Partnerships

The following subsections highlight key collaborations undertaken during the term, outlining their objectives, activities, and contributions to the growth and visibility of the LIS profession in Sub-Saharan Africa.

#### 5.1.CPDWL Collaboration:

A series of webinars were arranged in collaboration with the Continuing Professional Development and Workplace Learning (CPDWL) Section. Regional Division Chairs served as speakers, sharing experiences from their respective regions. This strengthened the SSA RDC's work on capacity building, particularly the development of emerging leadership. The most notable was the "Mentorship and Collaboration for Professional Development" webinar held on April 4th, 2025, featuring Francis Ssekitto (Uganda) and Buhle Mbambo-Thata (Lesotho). Insights from these engagements informed the development of the draft SSA-RDC Mentorship Strategy, which remains in progress for the incoming committee to operationalize.

#### 5.2. Bicentennial Celebrations of the Kingdom of Lesotho (20-24 August 2024):

The SSA RDC collaborated with the National University of Lesotho Library, Endangered Archives Programme Africa Hub, University of the Free State Library, Moshoeshoe Institute of Peace and Leadership, and the British Library. Activities included a conference on preserving national heritage and a pre-conference skills development workshop. Follow-up efforts supported the revitalization of the Lesotho National Library Association and strengthened professional networking in Botswana.

#### 5.. Other Notable Collaborations:

Contributed to the first edition of the IFLA Guidelines for Green Libraries (ENSULIB).

Coordinated with MLAS and AVMS to develop upcoming joint webinars.

Presentation of a collaborative paper for the Regional Council Open Session at WLIC 2025 titled "Strengthening Information Integrity in Sub-Saharan Africa: The Role of Libraries and Information Professionals in Combating Mis/Disinformation."

#### 6. Key Achievements:

- 1.Delivery of targeted webinars addressing mentorship, professional growth, and advocacy.
- 2.Development of the draft SSA-RDC Mentorship Strategy.
- 3.Increased visibility of SSA RDC through participation in global and regional LIS events.
- 4. Strengthened collaboration with professional associations and international partners.
- 5. Contributions to global IFLA guidelines and thematic initiatives.
- 6. Publication of newsletters showcasing the work of LIS professionals and students in the region.

#### 7. Challenges

- 1.Limited funding to support large-scale regional initiatives.
- 2. Connectivity and technological barriers affecting participation in virtual events.
- Resource constraints impacting project timelines and implementation

#### 8. Ongoing Projects and Recommendations

Finalize and operationalize the SSA-RDC Mentorship Strategy.

Continue advocacy for strong library associations across the region.

Expand collaborations with global and regional partners, especially in capacity building, research, and digital inclusion.

Enhance communication and outreach to ensure wider participation in SSA RDC programmes.

#### Conclusion

The 2023–2025 term has been productive and impactful, marked by strengthened regional collaboration, targeted professional development, and active contributions to global LIS discourse. The incoming committee is encouraged to build upon these achievements, sustain the momentum, and continue positioning the SSA RDC as a key driver of library development in Sub-Saharan Africa.

Report of the IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC)

**Business Meeting - Sunday, 17th August 2025** 

Venue: Altay, Congress Center, Astana Time: 08:45 – 10:45 (Astana Time)

The SSA RDC held its Business Meeting on Sunday, 17th August 2025 during the IFLA WLIC in Astana. The meeting was chaired by Dr. Monica Mensah Danquah (Chair-Elect, 2025–2027 term), who stood in on behalf of Dr. Ayanda Lebele, Chair of the 2023–2025 term. The meeting was attended by members of the Committee, observers, and guests.

#### 1. Welcome and Introductions

The Chair-Elect warmly welcomed members, observers, and friends of the region, expressing delight at the strong representation from across Sub-Saharan Africa. She emphasized the shared commitment to advancing libraries and information services in the region and highlighted the meeting as both an administrative and strategic platform to reflect, plan, and strengthen collaboration.

#### 2. Adoption of Agenda and Minutes

The agenda for the meeting was adopted without amendments. However, the adoption of the minutes of the Mid-Term Business Meeting of 8th April 2022 was adjourned, as several members were not present at the time. It was agreed that the minutes would be formally adopted at a later meeting once quorum was assured.

#### 3. Matters Arising

The Chair-Elect guided members through outstanding issues, including:

SCECSAL Engagement: Follow-up on regional engagement, with the next SCECSAL scheduled for 2026 in Zambia.

**Voluntary National Review (VNR) Participation**: Members noted limited participation due to funding constraints but were encouraged to remain proactive in national SDG processes.

**Advocacy:** Acknowledgement of advocacy tools developed by Damilare's team and concerns about participation levels.

**Library Networks:** Survey results showed 80% of countries have active associations, but challenges remain with funding and engagement.

**Capacity Building & Mentorship:** A draft SSA RDC Mentorship Strategy was submitted in September 2024; members were encouraged to review and operationalize it.

Strengthening Footprint in Member Countries: A hybrid workshop in Namibia for LIS students and early-career professionals was highlighted as a success.

**WLIC 2025 Paper:** Members noted the acceptance and presentation of the paper "Strengthening Information Integrity in Sub-Saharan Africa: The Role of Libraries and Information Professionals in Combating Mis/Disinformation" presented during the Congress.

#### 4. Report from the Chair (Delivered by the Chair-Elect)

On behalf of Dr. Ayanda Lebele, the Chair-Elect Dr. Monica Mensah Danquah presented a report on the 2023–2025 term, noting key achievements:

Expanded partnerships with IFLA professional units, AfLIA, SCECSAL, and the Climate Heritage Network (CHN).

Targeted webinars on mentorship and professional growth, e.g., the April 2025 session featuring speakers from Uganda and Lesotho.

Development of a draft SSA RDC Mentorship Strategy.

Stronger African presence at regional/global events (e.g., SCECSAL 2024, AfLIA 2025).

Contributions to IFLA Green Library Guidelines and other global initiatives.

Challenges included limited funding, digital connectivity issues, and the need to better engage Francophone members.

#### 5. Report from the Regional Office

The Regional Office (delivered by Lindi) updated members on:

South Africa's VNR planned for 2026.

LIASA's SDG-related advocacy work......

The importance of national librarians as government liaisons.

Participation in G20 initiatives and an upcoming AI conference with IFLA and the University of KwaZulu-Natal.

#### 6. Key Meetings and Programmes at WLIC 2025

The Chair-Elect Dr. Monica Mensah Danquah drew attention to sessions relevant to the SSA RDC, including the Regional Council Meeting, the SSA RDC Business and Caucus Meetings, and the joint Regional Divisions' Open Session on advocacy and collaboration. Members were urged to attend plenaries featuring the IFLA President and President-Elect to stay aligned with IFLA's strategic direction.

#### 7. IFLA WLIC 2026 - Busan, South Korea

Members were briefed on the next Congress to be held in Busan, South Korea. The Chair-Elect encouraged early preparation, collaboration across countries, and submission of papers reflecting African priorities. She also informed members of the new WLIC model for 2026/2027, and opened the floor for theme proposals for the SSA RDC's Open Session.

#### 8. Brief Reports from Member Countries

Representatives from different countries shared concise updates on developments and challenges within their national library sectors, including innovations in advocacy, professional development, and network strengthening. Reports received were mainly from Ghana, South Africa and Nigeria

#### 9. Special Remarks by IFLA Leadership

The meeting was honored by the presence of the IFLA President, the President-Elect, and the Secretary General, who welcomed the committee, commended the SSA RDC for its excellent work over the past two years, and encouraged continued advocacy and visibility for Africa within IFLA.

#### 10. Any Other Business

Members discussed the need to strengthen communication channels, enhance mentorship activities, and sustain collaboration with IFLA professional sections and regional partners.

#### 11. Closing Remarks

The Chair-Elect thanked members for their active participation, emphasized the importance of proactiveness, collaboration, and early planning, and reaffirmed the committee's commitment to advancing the IFLA Strategy and amplifying Africa's voice globally.

Report of the IFLA Sub-Saharan Africa Regional Division Committee (SSA RDC)

Caucus Meeting – Sunday, 17th August 2025 Venue: Conference Hall 3, Hilton, Astana

Time: 18:00 - 19:00 (Astana Time)

The Sub-Saharan Africa Caucus was convened on Sunday, 17th August 2025 during the IFLA WLIC in Astana. The meeting was chaired by Dr. Monica Mensah Danquah (Chair-Elect, 2025–2027 term) and brought together members, friends of the region, and observers for an open dialogue on strengthening the role and visibility of Sub-Saharan Africa within IFLA. An unofficial agenda was used to guide the session, but the format was kept flexible to allow for open discussions.

#### 1. Welcome and Opening Remarks

The Chair-Elect welcomed participants and noted that the caucus provides an informal but important platform to exchange ideas, reflect on progress, and set future priorities for the SSA RDC.

#### 2. Introductions and Open Floor

The session began with self-introductions from members and observers, followed by an open floor for comments. Participants highlighted their diverse backgrounds and reaffirmed their commitment to advancing libraries and information services across the region.

#### 3. Key Issues Discussed

#### **Communication:**

Members expressed the need for more consistent communication of information from the committee to members across the region. There was consensus on the need for a clear caucus strategy to consolidate regional solidarity and ensure strong leadership and active membership within the committee. This, members noted, would position Sub-Saharan Africa more effectively within IFLA's global governance structures.

#### **Future Priorities:**

Discussions also touched on succession planning, outreach for elections, and the need to mentor younger professionals to sustain strong representation in the years ahead.

#### 4. Special Remarks from IFLA Leadership

The caucus was honored by the presence of the IFLA President, the President-Elect, and the Secretary General, who joined briefly to welcome participants. They applauded the excellent work of the Sub-Saharan Africa Region over the past two years and encouraged members to continue building on this momentum. Their visit underscored IFLA's recognition of the region's contributions and its importance to the global library field.
