Installation and operation of IFLA/LAC's Regional Office in its new Headquarters represent for us new time and new oportunities. In the course of the 90's we will have the possibility of taking advantage of the innovating aspect of IFLA's Basic Program, ALP, to raise the level of librarianship in the Third World. The Latin American and Caribbean countries continue with their acute crises resulting from economic and social problems that have repercussions in the cultural areas, hence the necessity of the suport provided by IFLA's program.

Interaction and cooperation among the countries of the Region through the interchange of information, divulgation of news and working

out of projects by group of institutions or in one or more countries, will make possible the materialization of IFLA's proposals.

The Office's efforts to perform the functions assigned to it, thereby contributing to the development of Librarianship in Latin America and Caribbean, require a marketing work in order that the associations and institutions of the Region may provide help in the implementation of their proposals.

Several actions have already been identified, the Newsletter will have a regular periodicity and through circular letters we will maintain the continuity of the information interchange.

The Office automation, as far as its administrative and Calearinghouse functions are concerned becomes necessary in order to rationalize the services.

With all our tasks and with a working plan already prepared we are expecting the cooperation from all members of IFLA's Latin American and Caribbean Section during this stage of divulgation of the Regional Office.

NEWS IFLA AND HIS SECTIONS.

CONSERVATION AND PRESERVATION REGIONAL CENTRE, CARACAS, VENEZUELA (Lourdes Blanco, Director)

The Regional Centre for Latin America and the Caribbean has now completed two years of operation. During this two years period considerable progress has been made. In the area of information dissemination, a bibliography of the National Library's holdings in preservation has been prepared and distributed widely; a brochure of conservation and preservation services available through the Centre was developed; and several items have been translated into Spanish to increase their accessibility throughout the region. In addition, Ms. Blanco attended the annual meeting of ACURIL in Jamaica and presented a paper about the Regional Centre and its activities. In the area of training, staff of the Centre worked with the International Focal Point to develop text and pictures for the Unesco-funded AV programme on disasters, "Reaccion y Recuperacion ante Siniestros" and held a one-day seminar on disaster preparedness in July at which a draft of the programme was shown. In addition, a staff member from the University of Puerto Rico spent one month studying the operations at the National Library, including preservation. The Centre also provided consultation services to numerous libraries in the region and conducted surveys of collections in Quito, Ecuador; at the University of Cordoba, Argentina; and at the National Library of Mexico (IFLA Journal 16/2/90).

SALALM — SEMINAR ON THE ACQUISITION OF LATIN AMERICAN LIBRARY MATERIALS

Sponsored by the "Fundação Getulio Vargas" and "The Library of Congress Office", the

XXXV Seminar on the Acquisition of Latin American Library Materials took place in Rio de Janeiro, Brazil, from June 3 to 8, and had as its main theme "Continuity and Change in Brazil and the Southern Cone: Research Trends and Library Collections for the Year 2000".

The Seminar focused the transactions in the economy, politics, society, literature, science and technology, libraries and science of information as well as other aspects of knowledge in the region formed by Brazil, Uruguay, Argentina, Chile and Paraguay, besides the implications of these changes for the research and the bibliographic assets, from the 90s on. The sessions included panels, seminars and technical visits.

SALALM's main purpose is the control and dissemination of bibliographic information on all types of Latin American publications and the development of specialized collections of materials pertaining to the Latin American civilization and culture as a support for academic researches. SALALM cooperates with library services, besides addressing specific problems of Latin American and Caribbean librarians and supplying material for Spanish and Portuguese speaking persons in the United States.

PG1 AT THE 25TH SESSION OF THE GENERAL CONFERENCE

The Major issues debated on the UNESCO GENERAL CONFERENCE (Paris, 17 October —

16 November 1989) were the adoption of the Programme and Budget for 1990-1991 and the orientation of the new Medium-Term Plan (1990-1995).

The activities of the General Information Programme (PGI) in 1988 and 1989 were presented as well as the proposals for the coming biennium. The PGI programme received unanimous support both for its structure and its content. The proposal to amend the statutes of the PGI Intergovernmental Council in order to enable it to formulate recommendations for a better harmonization and co-ordination of Unesco information services was specially commended.

The structure of the Programme was appreciated as being clearly organized and the delegates insisted on the necessity to continue and strengthen PGI conceptual activities, in particular those related to standardization, the formulation of national information policies and training. The importance of international co-operation in the field of terminology was stressed.

Activities for improving the management and developing the modernization of libraries and archives should be continued. The establishment of and All-European Network of Scientific and Technological Libraries was considered favourably.

The progress in favour of the revival of the Alexandria Library was noted with satisfaction.

The proposed establishment and objectives of the Clearinghouse, which is to be created within the Unesco Secretariat, were well received among the delegates, many of whom insisted that it should be kept distinct from PGI, with its own budget and staff, while taking advantage of the Unesco Library and Archives whose services should be strengthened. During 1990-1991, priority should be given to the preparation of a feasibility study on the Clearinghouse and to on-line access to Unesco databases.

Aproved a Resolucion in General Conference concerning PGI for the biennium 1990-1991.

INFOLAC

1. What does INFOLAC means?

INFOLAC is the word which designates:

"The Regional Program for the Strengthening of the Cooperation among National Networks

and Systems of Information for the Development in Latin America and the Caribbean."

2. What is the goal pursued by INFOLAC?

The overall goal of the program is:

"To strengthen the individual and joint autonomy of the national institutions of Latin America and the Caribbean, in order to create and operate mechanisms of organization and access to information as well as to intensify its use in the formulation, accomplishment, evaluation and administration of their respective plans, programs, policies and actions of economic, social, scientific, technological and cultural programs."

SCIENTIFIC BOOKS SUPPLY TO THIRD WORLD COUNTRIES LIBRARIES

In the last years the services in development countries libraries have been rapidly deteriorating because of financial resources failure and principally the high costs of scientific books.

In this way, the Third World Academy of Sciences created a donation programme that takes in account solicitation of scientific books indispensable to the developing countries libraries.

PUBLIC LIBRARY OF RIO DE JANEIRO/BRAZIL

As a result of an agreement entered into by IBM-Brazil, Rio de Janeiro State Bank and Rio de Janeiro Public Library, the latter is implementing a Project named Public information Bank (BIP). BIP is an on-line system of information recovery to the interest of the Rio de Janeiro population.

Its main guidelines are the collection and organization of such information that are currently scattered in different federal, state and local public institutions as well as those from private institutions and associations. It also intends to make public libraries work as an information center able to indicate to the citizen where and when to get hes/her legal documents, as well as information, storage and supply centers for cultural events of Rio de Janeiro.

Implementation of the Project will go through different phases, the final one including direct information from computers located at specified public places.
