ADVANCEMENT OF LIBRARIANSHIP IN THE THIRD WORLD - ALP NEWS

• Workshop Libraries for the Blind, joint with the ALP Core Programme and the Section on Latin America and the Caribbean: Assessment of Needs on Library Service to the Visually Handicapped in Latin America and the Caribbean. The Workshop was coordinated by Beatrice Christensen Sköld, Sweden. The Workshop was a followup of the first Meeting, held in Habana, February 1993, which report was published in Newsletter 23. It was felt an evolution of the services from this first meeting. The continuity of meetings where one can feel the development of initial works had already had a good effect in our Region. • Open Forum of the Regional Division on Preservation and Conservation

ALP sponsored Ms. Flossie Matenje from Malawi, in Africa so that she could participate in the discussions about the cooperation concerning Preservation and Conservation between the different parts of the world which have been initiated by the Regional Division.

• Pre Session Seminar "Libraries for literacy in geographically and socially isolated communities", held in Matanzas, Cuba, at the Biblioteca Provincial, August, 1994 The ALP Office at Uppsala University, Sweden, was for the first time responsible for the administration on the international level, of the pre-seminar, for instance for the process to select the participants. This work took place in close cooperation with IFLA's Professional Coordinator and the Regional Division. The Professional Board of IFLA is responsible for the professional contents. IFLA's Regional Offices and Standing Committees clarified, por instance, their priorities for the selection of the candidates for the workshop, and influenced the programme. ALP paid for the attendance of one African and one Asian participant at the seminar. The translations of the papers into English and Spanish were also commissioned in Sweden. The local Cuban organizers under direction of Emilio Setien and Orlando Garcia were responsible for all other work and the rest of the financing and did suberb job. The Seminar was chaired by Barbro Thomas.

• Resolutions

Resolutions to IFLA:

be it resolved: that IFLA give priority to the establishment of a programme to promote literacy, linked to and supported by all relevant groups within IFLA

the IFLA Section of Public Libraries and the Section of School Libraries work together in close collaboration on school and public library relationships taking into account the national experiences of the various countries, especially the developing countries.

that IFLA urge its national association members and institutional members to work with their National UNESCO Commissions to ensure that the next UNESCO Programme and Budget and the next UNESCO MTP include a firm commitment to: a) the revival and preservation of the oral tradition; b) cooperation in the production and distribution of relevant reading materials in countries that have common languages and/or a common cultural experience; c) the production, distribution and promotion of materials in different formats for groups with special needs (for example: materials for the blind and other disadvantaged groups). Resolution to UNESCO: That UNESCO more actively inform library associations and institutions about published results of research in to literacy questions and reading promotion, and make these publications easily available to public libraries needing to use them.

• Central-American Workshop in Nicaragua ALP will organize the workshop "Advancement of Librarianhsip in the Third World - a Workshop to Identify and Assess Needs in Central America and to formulate project proposals", in Managua, Nicaragua, 6 · 9 March, 1995. Three representatives will be selected from each Central America country. As usual, the workshop is organized in close cooperation with the Regional Standing Committee for Latin America and the Caribbean. Members of the Standing Committee from Middle America will assist at the workshop and function as resource persons. The National Library "Ruben Dario", of Nicaragua will be responsible for a great part of the planning and all local arrangements. The working language will be Spanish. We hope that representatives of UNESCO PGI in Caracas, Venezuela will also assist.

• Future ALP projects in Latin America The Swedish Internacional Development Agency, SIDA has in October 1994 decided to support the following projects in Latin America: The Central American Workshop mentioned above: Survey of national information resources and services in the member states of the OECS and review of plans for development; Continued development of INFOBILA; Creation of an association for South Cone library schools, the last phase: A practical workshop in Peru to compare experiences from services to minorities in remote or border areas in co-operation with the neighbouring countries. SIDA has also included money to cover the Regional Office's cost for its work with ALP

activities, and some money for the planning of projects.

• Database/ Guide of Institutions that support librarianship in developing countries. This project is being conducted by ALP with financial support from the Ministry of Foreign Affaires, Denmark, DANIDA. The questionnaire is being sent by ALP. The Regional Office has a copy of it to send to persons willing to provide information for this database.

• On August 15-16, 1994 it was held in São Paulo, an International Symposium on Copyrights and Publisher's rights, Colective Administration and Reprographic Rights, sponsored by CERLALC and the Associação Brasileira de Direitos Reprográficos, ABDR. The librarians: Rosaly Krzyzanowski, coordinator of the University of São Paulo Library System, SIBI, Rosa Maria R. Correa, manager of the library of the Memorial da América Latina, and May B. Negrao, consultant, special advisor of the IFLA Section of Latin America and the Caribbean presented papers on the session Librarians and Reproduction.

• The II Meeting of Portuguese Speaking Librarians held in April 3-8, Niteroi, Rio de Janeiro, organized by the Brazilian Federation of Library Associations, FEBAB, promoted by FEBAB and by the Portuguese Association of Librarians and Archivists (BAD), ended up with the Declaration of Rio de Janeiro with proposals of projects and actions to be undertaken by Brazil, Portugal and by the African Portuguese speaking countries which had been discussed at the CAUCUS OF PORTUGUESE SPEAKING LIBRARIANS, held in the IFLA Conference in Havana. Thirty professionals participated in this meeting.

• Maria da Conceição Vasques Araujo Tali, from Luanda, Angola, published in the *Cadernos BAD*, Lisboa, 2: p.29-53, 1993 the article entitled *Libraries in Luanda, Angola: problems and prospects* with proposals of many actions to be undertaken for the development of libraries in this African country that can be the object of tripartide (Africa, Brazil and Portugal) projects to be presented to the ALP Program. • FEBAB proposed to IFLA that Portuguese be considered another official language. An agreement on the areas of interchange and cooperative education between Mexican and American Institutions, the Escuela Nacional de Biblioteconomia y Archivonomia (ENBA) and the School of Library and Information Sciences, University of North Texas (UNT) made possible this workshop held in 9 and 10, September, at the Antigua Hacienda de Galindo, San Juan del Rio, Querétano. Both institutions felt an urgent need to analyze the education of librarians face the challenges libraries face with the development of new technologies and the infraestructures of telecommunications. Some of the themes that were discussed: the desirable knowledge librarians need to face the challenges of a new era and also the leadership needed, theory and practice of library activities, the integration of technological and human aspects. Participants from the School of Library and Information Sciences presented papers in subject such as: Illustrated communications, Libraries and Technological Information, Communication through computers and its use in public schools, Toward the coordination of the cognitive and algorrhythm research in information retrieval. The Colloquium was a space for reflexion on the situation of library systems in Mexico and in the United States to identify similarities and differences.

• El Plan Lector de Cajas Viajeras del Programa Lectura para Todos (Traveling box Reader, Program Reading for all), Fundación Comisión Nacional de Lectura (FUNDALECTURA), started in 1990, and has already reached 5000 teachers who followed refresher courses on reading

modern theories, 263 teachers took specialized courses as reading mediators and 200,000 children received the benefits of books and special teaching practices). There are 185.840 copies being used. The reading plan is based in four great strategies: acess to materials with interesting themes and high quality of edition and illustration for children during the first stage of education; the updating of teachers of the first three years of basic education in modern theory and practice of reading skills and promotion of reading; motivate parents and the whole population on the importance of reading and its effect on the country's development; research on the results on teaching practice after the continuous education program.

• The Biblioteca Nacional undertook the Project Los Cardones as a pilot experience in community's building of a library service, a simple structure building. The project involves the community since the first draft of the building, trying also to retrieve traditional building technologies.

• Bookmobile Amazonas. The Biblioteca Nacional started a new project of Mobile Libraries designing a new bus that travels by land and is adapted to the climate and topography of the State of Amazonas.

• LETTER OF HAVANA, 1994 - 60th IFLA General Conference, Cuba 94

The 60th. IFLA General Conference, held in the city of La Habana, in August 1994, was the meeting point of more than 1200 librarians from Latin America and the Caribbean, an adequate site for the interchange of knowledge and experiences, that despite specific situations due to common social, cultural economic factors, are unknown to the rest of the region. During the official sessions of the IFLA Section of Latin America and the Caribbean topics related to strenghtening the interaction and collaboration towards librarianship development among the countries in the Region have been discussed.

This was the feeling that animated the Latin American delegates in gathering, knowing each other and state their need of information concerning library activities in their countries and in concluding that there is a possibility of establishing mechanisms that could allow the continuity of this dialogue and perhaps make real the words of the Lic. Elsa M. Ramirez Leyva (México), in her paper presented at the General Conference "... It would be much more important this global presence than individual efforts to consolidate a position within the social structure".

This intent of cooperation and of interchange of information started with a dialogue between the Asociación de Bibliotecarios Graduados de la República Argentina (ABGRA) and the Asociación Cubana de Bibliotecarios (ASCUBI), that stated seven initial points for agreement to be subscribed by the representatives of both institutions.

From this first approach and as a result of conversations with Dr. Fernando de Martino, (Business Attaché of the Republic of Argentine Embassy in Cuba) Encargado de Negocios, Embajada Argentina in Cuba, both Cuban and Argentine Chancellors got interested and came to terms on the possibility of reaching a cooperation agreement from a letter of intention endorsed by the delegates of the countries interested in this proposal. The seven points that have been accepted by ABGRA and ASCUBI, have been analyzed by representatives of the Asociaciones de Bibliotecarios de Chile and Colombia and by the IFLA Regional Office for Latin America and the Caribbean that adhered to this project.

To the initial proposal, 4 additional points were added concerning preservation of cultural heritage. Another meeting was held to analyse and vote on the 11 points of the LETTER OF HABANA, 1994, the beginning of an agreement that will certainly become official, following the steps already given by both Chancellors of Argentina and Cuba.

This Letter of Intention was presented to Mr. Leo Voogt, IFLA General Secretary, in a meeting

with the presence of the representatives of IFLA Regional Office for Latin America and the Caribbean, Lics. Elisabet M.R. de Carvalho and Ivone Tálamo, ABGRA General Secretary, Lic. Claudia Rodriguez and the Vicedean of the Universidad del Museo Social Argentino, Lic. Adriana Adamo.In this meeting, the IFLA General Secretary complied with the agreement, encouraging the parts involved to continue their work toward its goal and asked ASCUBI President, Mrs. Marta Terry to announce, during the Conference Closure Ceremony, the signing of the document and to invite all countries in the Region to adhere to this cooperation and interchange assignment stated in the letter which text is reproduced below:

LETTER OF HAVANA, 1994 - PROJECT OF AGREEMENT BETWEEN LIBRARY ASSOCIATIONS AND INSTITUTIONS IN LATIN AMERICA AND THE CARIBBEAN

- 1. Interchange of information materials.
- 2. Joint researches on scientific and technological librarianship themes.
- 3. Edition of joint publications on librarianship researches.
- 4. Continuous education and training of professionals and teachers, by the parties involved .
- 5. Interchange of teachers and researchers, through offered courses on library and scientific- technological information.
- 6. Realization of specialized joint workshops and conferences on library science subjects aiming at the interchange of experiences in this field.
- 7. Interchange of experiences and projects in library and information sciences.
- 8. Promotion of the education, updating and training on preservation and conservation of our cultural heritage.
- 9. Establish the development, research and the accomplishments of programs on conservation and preservation of Latin America and the Caribbean cultural heritage.
- 10. Support the development and application of standards for the preservation and conservation of the cultural heritage aiming at the unification of criteria.
- 11. Establish and maintain relations of interchange and cooperation with institutions with common objectives.

Conference, Cuba, 1994, in the city of Havana, subscribe to this letter of intention to propose 11 points aiming at a forthcoming multilateral agreement between Library Associations and Institutions, representatives of cultural organizations and experts of Latin America and the Caribbean, on August 27, 1994.


