Member States' assessed contributions to UNESCO's regular budget for 2025

1. The contributions due from Member States to UNESCO's regular budget for 2025 are assessed in accordance with:
 - The provisions of Article 5 of UNESCO's [Financial Regulations](#) relating to the remittance of contributions by Member States, in particular Article 5.5. stating that contributions to the regular budget and advances to the Working Capital Fund shall be considered as due and payable in full **within 30 days** of the receipt of the communications of the Director-General;
 - 42 C/Resolution 80 stating that:
 - the assessment on Member States is USD 685,444,872 for 2024-2025 i.e. USD 342,722,436 for 2025;
 - where the annual assessed contribution for a Member State is:
 - less than USD 200,000, that Member State's contribution shall be assessed in USD only,
 - USD 200,000 or more, that Member State's contribution shall be assessed in both EUR and USD in accordance with the split percentage of 47% in EUR and 53% in USD, calculated at the budget rate of USD 1 = EUR 0.913.
 - 42 C/Resolution 58 maintaining the level of the Working Capital Fund to USD 36.6 million;
 - Financial Rule 105.2 stipulating that unless the amounts assessed are received **simultaneously and in full** in the currencies in which they are assessed, credit shall be given against contributions due in proportion to the amounts assessed in both currencies using the UN operational rate of exchange prevailing at the date of receipt;
 - 26 C/Resolution 23.1 paragraph f) stating that the assessment of Associate Members shall be fixed at 60 per cent of the minimum rate of assessment of Member States and their contributions shall be accounted for as miscellaneous income.
2. In accordance with Article 6.2 of the [Financial Regulations](#), Members States may make voluntary advances to complement the level of the Working Capital Fund.
3. In line with 38 C/Resolution 84.III on the incentive scheme for prompt payment of contributions, Member States who pay in full their contribution by **28 February 2025** and have no outstanding payment plans will be eligible to receive a discount corresponding to the effective interest earned between the date of payment and the end of June 2025. The date of payment shall be considered to be 1st January 2025 if the contribution is received in advance. The discount earned in 2025 will be calculated in 2026 when closing 2025 accounts and deducted against 2027 assessment.
